QUESTION OF EAST TIMOR

Algeria, Angola, Barbados, Fenin, Botswana, Cape Verde, Tquatorial Guinea, Grenada, Guinea, Guinea-Bissau, Malawi, Hozambique, Micaragua, Saint Lucia, Sao Tome and Principe, Seychelles, Sierra Leone, Swaziland,

Uganda and Zimbabwe: draft resolution Lesollo, Congo, Trimidad and Tobaso, Juyana

The General Assembly,

Recognizing the inalienable right of all peoples to self-determination and independence in accordance with the principles of the Charter of the United Pations and of the Declaration on the Granting of Independence to Colonial Countries and Peoples, contained in its resolution 1514 (XV) of 14 December 1965,

Considering that the international community is celebrating in 1080 the twentieth anniversary of the Declaration,

Bearing in mind that the Fifth 1/ and Sixth 2/ Conferences of Weads of State or Government of Mon-Aligned Countries, held at Colombo and Havana, in 1976 and 1979, respectively, reaffirmed the right of the people of Fast Timor to self-determination and independence,

Having examined the chapter of the report of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples 3' and other relevant documents 4/ relating to the Territory,

Taking also into consideration the diplomatic initiative taken by the Government of Portugal with a view to finding a comprehensive solution to the problem of East Timor,

Deeply concerned at the continuing suffering of the people of East Timor as a result of the hostilities still prevailing in the Territory,

Having heard the statements of the representatives of Portugal, 6/ as the administering Power, and Indonesia, 7/

Having also heard the statements of various East Timorese petitioners and representatives of non-governmental organizations, as well as the representative of the Frente Revolucionária de Timor Leste Independente,

- 1. Reaffirms the inalienable right of the people of East Timor to selfdetermination and independence, in accordance with the Declaration on the Granting of Independence to Colonial Countries and Peoples contained in General Assembly resolution 1514 (XV);
- 2. Declares that the people of East Timor must be enabled freely to determine their own future under the auspice of the Walter Practice of the Walter fractions ork;
- 3. Welcomes the diplomatic initiative taken by the Government of Portugal as a first step towards the free exercise by the people of East Timor of their right to self-determination and independence, and urges all parties directly concerned to co-operate fully with a view to creating the conditions necessary for charge the speedy implementation of General Assembly resolution 1514 (XV); the france this to "overall settlement" leaving out relf determination + independence this to 4. Expresses its deepest concern at the continued suffering of the people
 - of East Timor as a result of the situation still prevailing in the Territory:
 - 5. Requests the United Nations Children's Fund, the World Food Programme and the office of the United Nations High Commissioner for Refugees to render, within their respective fields of competence, all possible assistance to the people of East Timor, particularly the children;
 - 6. Requests the Secretary-General to follow the implementation of the present resolution and to report to the General Assembly at its thirty-sixth

session on all aspects of the situation in East Timor, in particular, the political developments concerning the situations referred to in paragraphs 1, 2, 3 and 4 above;

7. Decides to include in the provisional agenda of its thirty-sixth session an item entitled "Question of East Timor".
