At the invitation of APPTL, the bishop of Sehíbal spoke before the UN Special Committee on Decolonization in 1987. In 1990 he collects 167 letters of bishops from Europe, Africa and the Americas to support the request for a referendum launched by Mons. Belo. He wants to deliver the letters to the UN S.G. but the Vatican forbids it.
